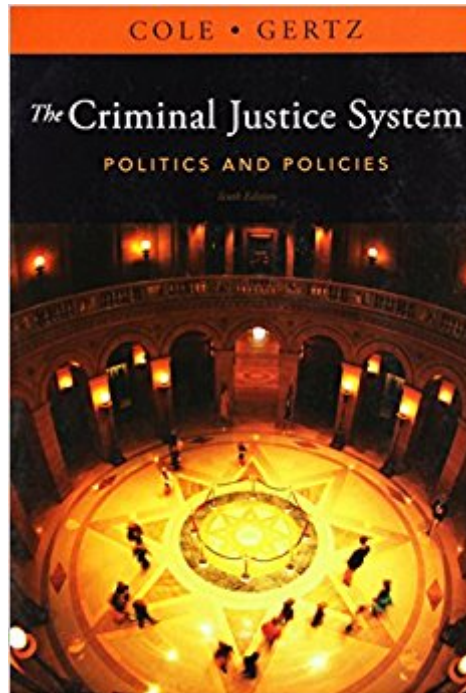

The late George F. Cole was Professor Emeritus of Political Science at the University of Connecticut. He was recognized for outstanding teaching and research and in 1995 was named a Fellow of the Academy of Criminal Justice Sciences. A specialist in the administration of criminal justice, he published extensively on such topics as prosecution, courts and corrections. He developed and directed the graduate corrections program at the University of Connecticut and was a Fellow at the National Institute of Justice (1988). Among his other accomplishments, he was granted two awards under the Fulbright-Hays Program to conduct criminal justice research in England and the former Yugoslavia. He co-authored several other Cengage Learning/Wadsworth

criminal justice titles, including THE AMERICAN SYSTEM OF CRIMINAL JUSTICE, AMERICAN CORRECTIONS, AMERICAN CORRECTIONS IN BRIEF and THE CRIMINAL JUSTICE SYSTEM: POLITICS AND POLICIES. Marc G. Gertz is a professor at Florida State University, where he has been a member of the faculty since 1976. His interests include public law/judicial process and behavior, administration of criminal justice, public administration/organization theory, public policy in the criminal justice system, American politics, and research methods. He received his Ph.D. from The University of Connecticut, Storrs.
