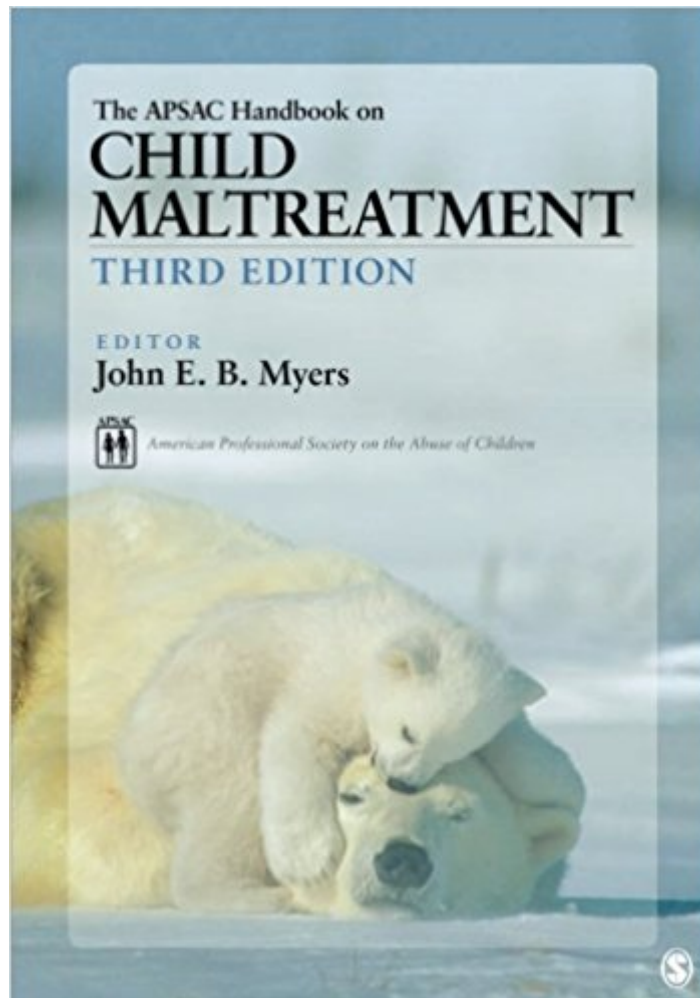

He is the author or editor of eight books and more than 100 articles and chapters on child maltreatment and his writing has been cited by more than 140 courts, including the United States Supreme Court. John is a frequent speaker at

conferences, having made more than 400 presentations around the world.

I was very disappointed with the 3rd edition. In my clinical training working with maltreated children, the 2nd edition was an essential and comprehensive resource for research, assessment, and treatment guidance. I ordered the new edition in preparation for providing expert testimony on a CSA case believing the testimony sections would be just as comprehensive as the prior with updated research and practice guidelines. Not so. Also the prior edition canvasses many essential areas of child maltreatment including young children, comorbid sexual/aggressive behavior problems, etc. In great detail. Again, not so. I noticed the prior edition had several editors and contributors which is no longer the case. I fear that without multiple voices the current edition suffers from fewer perspectives which was a great strength of the prior editions. I only hope the next edition does it better.

I got this as my professional involvement in the field of child abuse was ending. I've published two books in this field and read a ton of stuff in the field as well. I recognized that this offers profound and new ideas about child maltreatment. For anyone working actively in the field, I would encourage you to read this work. Anything that APSAC (The American Professional Society on the Abuse of Children) puts out is going to be reliably good. If there is a chapter in your area and you work in the field, join. You will be connected with the movers and shakers in this field. At least, I was in Washington State.

This volume is indeed a comprehensive work that could serve as a stand alone source for Child Abuse and Neglect teaching, research, or training for practice. It is a helpful resource that I will keep throughout my professional career. I will say that there are grammatical imperfections throughout, and occasionally the implied outline of particular chapters is difficult to follow.
